The Committee participated in a roundtable of discussions with the following main themes captured:

- Concerns were raised around the lack of windows on the front elevations on the upper floor;
- Concerns were raised that the initial feedback and comments from the ADP were not addressed in the revisions presented in today's meeting;
- Lack of privacy between the homes and the lack of natural light was identified again as a recommendation for review;

- It was identified that the backyards were not an effective use of space and the recommendation was made to review the location of the siting of buildings on the lots; and
- Review of parking on site and on the street was identified as a concern.

It was **MOVED** and **SECONDED** THAT the Advisory Design Panel:

Request the Development Permit Application for 19072 Advent Road return
to the Advisory Design Panel after addressing the recommended changes and
comments related to privacy, the front façade addition of windows on the
upper floors, increased access to natural light, on site parking and revisions
to the locations of the homes on each lot to allow for larger backyard
outdoor areas.
