There was general consent amongst the Committee to approve the October 25, 2023 Community Support & Accessibility Committee agenda..

4. ADOPTION OF MINUTES

There was general consent amongst the committee to approve the minutes from the June 28, 2023 Community Support Select Committee meeting minutes as circulated.

5. **NEW BUSINESS**

5.1 Updates from Community Outreach Agencies

Community Outreach Agencies participated in a roundtable discussion providing a verbal update on their individual organizations.

H. Treleaven, Seniors Network Update:

- It was announced that the new Seniors Resource Directory magazine has been published and distribution is underway. Currently available at the Pitt Meadows Seniors Centre, online at www.seniors-network.ca as well as the Pitt Meadows Library;
 - There was discussion on other possible locations and it was advised that coordination of packages to organizations upon request is available;
 - It was suggested that copies be available at the Pitt Meadows
 Recreation Centre for local seniors who utilize the facility; and
- It was reported that there is increased attention to the results of the recent Homelessness Services Association of B.C. survey showing a 17% increase in homeless seniors in Ridge Meadows.

C. Shearme, Community Network Update:

- It was shared that the current focus for the Community Network is to move forward on learning for Truth and Reconciliation, with a focus to start locally on Pitt Meadows history;
- It was shared that another Community Network focus is on stigma reduction for drug use in the Ridge Meadows community; and
 - It was shared that increasing visual representation for support is needed to reduce the stigma.

A. Sanchez, Fraser Health Update:

- It was shared that food insecurity is a major focus for Fraser Health;
 - Currently focused on coordinating different organizations while
 Fraser Health to act as facilitator instead of project managers;
 - Facilitation for cooperation between local Ridge Meadows farmers and School District 42 to coordinate produce donations for children in need;
 - Applying for grants to work on building more community gardens and specifically more funding and resources to the Pitt Meadows community gardening initiatives;
- A diversity report was shared, forming a part of the minutes as Attachment
 1;
 - Report includes data on visible minorities, immigrants, age/language plus general health indicators which profiled food anxieties and depression as the top mental health issues for the Ridge Meadows community;
- Fraser Health is also looking to involve senior volunteers in schools to help with food literacy and hands on experiences, to make soups and salads as well help with distribution of fruit and vegetable programs.

M. Robson, Friends in Need Food Bank Society Update:

Councillor G. O'Connell shared an update provided by M. Robson via email, which forms a part of the minutes as Attachment 2.

 The Committee would like to invite Hudson Campbell to come to a CSAC meeting to encourage more Youth/Young Adult representation to local community issues and bridge the gap between youth and seniors.





Diversity Profiles Summary: Maple Ridge - Pitt Meadows
























General Health Indicators Profiles Summary: Maple Ridge - Pitt Meadows




PREVALENCE RATE FOR SELECTED CHRONIC DISEASES





I am out of town and really do not have much to update. Following are a few updates:

- The current number of households we are serving in Pitt Meadows is 117 with about 300 members. New registrations have slowed down slightly with only 13 in the last four months.
- The school meal snack program is back up and running and I am pleased to report that SD42 will be providing some funding towards the cost of dairy product being bought and supplied to the schools.
- There have been several food drives in September/October. The BC Thanksgiving Food Drive covers a few routes in Pitt Meadows. The newest food drive which we hope to become an annual event is the Purolator Tackles Hunger which participated in one area in Maple Ridge, but in discussions with Purolator organizers, we all agreed we would like to see more areas in Pitt Meadows included.
- The Pitt Meadows Food Bank will be closed for the week of November 13 due to staff holidays, but clients will be able to attend Maple Ridge if needed. The volunteers are good about handing out extra product prior to the closure.
- The CP Holiday Train will return December 17 and the Firefighters for Families will shake their boots at six locations in Pitt Meadows on Saturday December 9.
