- <u>Cameron Waldbauer</u>, Pitt Meadows Regarding the backflow preventers and the recent installation requirements from the City identifying financial burdens, annual costs, and risks analysis.
- <u>Julie Paciejewski</u>, Pitt Meadows Regarding the backflow preventers suggesting that this be added as infrastructure and maintenance to be maintained by the City who should bare the costs for all upgrades and maintenance.
- Herman Hoffman, Pitt Meadows Concerns around the costs associated with the installation of backflow preventers, the reduction in water pressure, potential power outages and the risk of freezing.
- <u>Eric Letenhorst</u>, Pitt Meadows Concerns around the cost associated with installation and the location requirements for the backflow preventers.
- <u>Dave Captein</u>, Pitt Meadows Regarding installation of backflow preventers and whether homes in the urban core will require the installation, concerns regarding reduced water pressure, costs associated with annual inspections and maintenance, and concerns around potential for loss of power which could lead to freezing in cold temperatures if a generator is not purchased as well.

H. <u>REPORTS</u>

H.1 Pitt Meadows Recreation Centre - Youth Lounge Update

Carleen McDowell, Manager of Recreation & Culture provide an update on the recent fire that took place in the Youth Lounge located inside the Pitt Meadows Family Recreation Centre. Some of the highlights included:

- The full scope including the cost of the damage is unknown;
- Staff anticipate the Youth Lounge to remain closed for the next 3-6 months;

- Loss of Youth Lounge has impacted the community youth and user groups; and
- In response to the fire in the Youth Lounge, Staff have been repositioned into the north end of the Pitt Meadows Family Recreation Centre lobby to provide youth in the community with support needed offering a safe place for youth to socialize and connect in our community.

 water contamination suggesting installation of backflow preventers to be
 installed at a lower cost inside homes instead of at the property line. Further
 comments regarding cost to install a backflow preventer at the edge of the
 property line which if borne by farmers would increase operational costs which
 would be pass along to consumers.
- <u>Leo Captein</u>, Pitt Meadows Regarding the install of backflow preventers on properties located in the rural areas of Pitt Meadows and whether there was any evidence to assume there were any current risks.
