

Re: Job #088373 Application for Cannabis Retail Store Licence Applicant: Kelo Retail Corp. Proposed Establishment Name: Kelo Cannabis Proposed Establishment Location: 112 – 19150 Lougheed Hwy, Pitt Meadows

The City of Pitt Meadows has considered the above application with regards to the general impact of the proposed store on the community, including the evaluation criteria outlined in Council Policy C108: Cannabis Retail Stores. The proposed site is located in a retail shopping centre, with adequate parking and transit service. The nearest park and playground is located over 250 m away, and the nearest elementary school is greater than 400 m away.

To gather the views of nearby residents, a sign was posted on the property at 19150 Lougheed Hwy on November 28, 2023 to February 27, 2024, notifying members of the public about the application. The City also held a public hearing on the application on February 6, 2024. Notification of the public hearing included mailed notices to all residents and businesses within 122 m of the property at 19150 Lougheed Hwy (948 notices), two advertisements in the local newspaper, and information posted on the City's website. 14 written submissions were received in advance of the public hearing, both in support and in opposition. At the public hearing, there were three speakers, two of whom were the applicant and the other a resident.

The main concerns identified were in relation to the potential for on-site consumption and smoking, noise, and smell.

Submissions received in support of the application noted the desire to have this type of retail service in Pitt Meadows, so that residents do not have to travel outside of the community to access cannabis products.

As the application is consistent with the City's Cannabis Retail Store policy, and with consideration of feedback received during the public hearing, the City recommends that the licence be issued.

Appendix A: Public Hearing Summary

Public Hearing

February 6, 2024 / Regular Meeting of Council

This is an excerpt of the Minutes of the February 6, 2024, Regular Meeting of Council, as it relates to the Public Hearing for Rezoning Application for #112 – 19150 Lougheed Highway.

Item: D.1 Public Hearing for Rezoning Application for #112 – 19150 Lougheed Hwy

Mayor MacDonald opened the public hearing at 7:02 p.m.

Colin O'Byrne, Manager of Planning, presented an overview of the bylaw and historical staff reports related to the rezoning application for #112 – 19150 Lougheed Highway. Fourteen (14) written submissions were received prior to the conclusion of the public hearing and form part of the original minutes as Attachment 1.

Mayor MacDonald then read aloud the public hearing process statement and invited members of the public to make comment for the first time. The following members of the community took part in the public hearing opportunity:

<u>Bob Wray</u>, Pitt Meadows – regarding prohibition of retail cannabis sales in Pitt Meadows. Expressed his desire for alternate retail outlets in Pitt Meadows of a more essential nature.

<u>Ted Ribeyre (Applicant)</u>, Port Coquitlam – regarding their contributions to the local community, dedication to business ethics and assurance to the community to follow all regulations in Pitt Meadows.

<u>Vadim Gramuglia (Applicant)</u>, Pitt Meadows – regarding the requirements that cannabis retail establishments are required to follow and that public safety is one of their top priorities.

Mayor MacDonald invited members of the public to make comment for the second time, with the following member of the public engaging:

<u>Bob Wray</u>, Pitt Meadows – regarding clarification of the City's Zoning Bylaw amendment and City Policy that speak to retail cannabis.

Mayor MacDonald invited members of the public to make comment for the third and final time. With no additional members engaging, the public hearing was declared closed at 7:21 p.m.
