#### PURPOSE

To propose minor amendments to the Waterworks Bylaw in relation to backflow prevention, typical details and permit fees.

#### **DISCUSSION**

#### Background:

Backflow requirements have been included in the Waterworks Bylaw for many years and outlined the highest level of backflow device for all rural connections. The cross-connection control program and associated Cross-Connection Control Policy C022 were implemented in 2010, following an assessment of the City's water system. Since that time, the City has taken steps to bring various higher risk properties into compliance. In September 2023, the City launched another round of informational letters to various residence's in the agricultural areas, informing them of the backflow requirements and Owner responsibilities. Following further discussion research and feedback, the City has established two compliance pathways for properties with agricultural uses and/or activities. The revised approach would still require the highest level of backflow device (Reduced Pressure Backflow Assembly – RPBA) for actively farmed properties or properties with other sever risk activities. It would also permit a medium level backflow device for properties that are not actively farming or have any other severe risk. This is generally an operational program, but triggers amendments to the City's Waterworks Bylaw (mainly Schedule C of the bylaw). The main changes are outlined in the analysis section below.

## Analysis:

Following a high-level review of the Waterworks Bylaw to ensure compliance with the City's backflow prevention initiatives and other housekeeping items, the following amendments are proposed:

- Added reference to Section 17 [Municipal Action at Defaulter's Expense] and 18 [Authority to Discontinue Providing a Service] of the *Community Charter*;
- Addition of the American Water Works Association's Canadian Cross-Connection Control Manual in the definitions;
- Revisions to Section 11 [Temporary Reduction or Discontinuance of Service] to define a notice period and a Consumer's right to reconsideration in alignment with the *Community Charter*;
- Clarity added to Section 25 [Backflow Prevention] to clearly outline the Director, Building Official and Owner responsibilities. A subsection has also been added outlining that the City may conduct works in the event of continued non-compliance and chargeback the costs through taxes;
- Slight modification of water turn on/off fees, permit and application fees to be more inline with the efforts required. The increase in fees ranges from \$50 - \$100; and
- Removal of the Typical Water Connection Details in Schedule C and D. Schedule C is no longer accurate, but specific details will still be used by staff at the operational level, where appropriate.

City staff plan to undertake a fulsome review and update of the City's Cross-Connection Control Policy C022 and bring forward proposed amendments later in the year for increased clarity.
