#### F. CURRENT PRIORITIES

#### F.1 Tourism Development

Colin O'Byrne, Manager of Planning, presented an overview of Tourism Development in Pitt Meadows including the following highlights:

- Destination BC research;
- The City's policy framework.

Guy Miller, Pitt Meadows Airport Manager, presented an overview of the airport's marketing campaign and efforts to attract and increase tourism to the community.

Committee members participated in a roundtable discussion.

Colin O'Byrne continued the presentation sharing the following information:

- Overview of Hopcott Farm's initiatives;
- Tourism amenities and special events in Pitt Meadows;
- Recent and ongoing initiatives; and
- Scenic Route 7 and Destination BC initiatives.

Committee members participated in a roundtable discussion sharing the following feedback:

- Consider initiatives geared towards incorporating the wedding industry;
- Consider food truck festivals held at YPK;
- Restaurant & cycling tours [bites and bikes];
- Potential for an incline trail akin to Coquitlam Crunch;
- Connect with travel agent's to gather feedback;
- Capitalize on cycling groups;
- Importance of highlighting what Pitt Meadows is [ie: cranberry fields, fishing, farms]; and
- Importance of supporting / celebrating Pitt Meadows.

Mayor MacDonald then opened the floor to members of the public to engage in two way dialogue.

The following community member participated in the public engagement opportunity:

 <u>Patricia Gordon</u>, Pitt Meadows - regarding the significant turnout and success of the Ridge Meadows Minor Baseball Association's tournament for Rumble in the Ridge.

# F.2 Proposed Zoning Bylaw Amendments Related to Uses of Agricultural Land

Patrick Ward, Director of Planning & Development, introduced the topic and presented a brief outline of the Staff Report.

Allison Dominelli, Planner, continued the presentation sharing an overview of proposed amendments to the City's Zoning Bylaw.

Committee members participated in a roundtable discussion and expressed general support for the proposed amendments. Additional comments included:

- Regarding "Parking & Vehicles":
  - Clarification of how 'containers' are defined;
  - Clarification of resident property owner or resident;
  - Enforceability of restrictions;
  - Clarification if parade floats or vintage vehicles are included in definition;
  - Clarification on the number of dump trucks permitted on farm property; and
  - Clarification of RV storage on ALR land.
- Regarding "Size Limit of Single-Family Dwellings":
  - Importance of maximizing the use of the land for farming;
  - Clarification of impacts to secondary dwellings and impacts on size.
- Regarding "Accessory Residential Structures":
  - Clarification of what the additional space could be used for.
- Regarding "Garden Suites on parcels less than 8094 m<sup>2</sup>":
  - Clarification of differences between septic requirements and inspections for garden suites versus secondary suites;
  - Current farm use status for impacted properties;
  - Importance of considering aging in place / multi-generational families; and
  - Supportive of public consultation.
- Regarding "Temporary Farm Worker Housing":
  - o Clarification of threshold for workers by commodity.

Mayor MacDonald then opened the floor to members of the public to engage in two way dialogue.

The following community member participated in the public engagement opportunity:
