# **DISCUSSION**

#### Background:

Attached to this report is the final version of the Parks, Recreation and Culture Master Plan which brings together the research, engagement, consultant recommendations and community feedback. The delivery of this document represents the final phase of the process.

# Analysis:

The draft document was presented for Council consideration on October 5<sup>th</sup> during the EPC meeting. Staff connected with user groups and individuals that participated in the engagement sessions to encourage them to review and submit feedback. Additional feedback was saught using the Have your Say Pitt Meadows website from October 5-22<sup>nd</sup>, with 36 individuals visiting the site during this time.

The consultants reviewed the additional information and feedback and incorporated the following into the document.

Added an additional reference to Pitt Meadows Day ("Did You Know Profile")	<ul> <li>Feedback during the previous Council presentation</li> <li>Feedback through the online review process</li> </ul>	
Added additional references / content re: sustainability, conservation and climate leadership	<ul> <li>Internal feedback from staff that additional references and direction was needed</li> <li>Feedback through the online review process</li> </ul>	
Heritage and Memorial Amenity Strategies, Action C. Re-wording of contemplative space to place of remembrance and further direction on next steps (investigation of space characteristics and site analysis)	<ul> <li>Council and staff feedback that more clarity was needed</li> <li>Consultant's recommendation that this space requires more exploration</li> </ul>
