K.3 Bylaw Service Review – Next Steps

Anne Berry, Director of Planning & Development, provided an overview of the Staff Report including a PowerPoint presentation which is included as Attachment 2 and forms part of the original minutes.

Council members participated in a roundtable discussion and provided the following feedback to staff to consider:

- Addition of parameters for proactive vs complaint based enforcement;
- Abusive or bullying behaviour from residents should not be tolerated and may be grounds for closing a file or escalating enforcement;
- Inclusion of standards/process for correspondence with complainants; and
- Time limits for voluntary compliance.

It was **MOVED** and **SECONDED** THAT Council:

- A. Direct staff to revise Council Policy C014 'Complaints and Bylaw Enforcement' to include additional best practices and improve clarity to the public around bylaw enforcement as outlined in the Staff Report titled "Bylaw Services Review Next Steps" dated November 29, 2021; AND
- B. Direct staff to review the Bylaw Notice Enforcement Bylaw No. 2439, 2009 to ensure all fines are adequate.

K.4 Council Policy C015 - Public Consultation Meetings: Policy for Developers

Mayor Dingwall introduced the topic as a result of a recent public consultation session that raised concerns amongst residents near a proposed development site.

It was **MOVED** and **SECONDED** THAT Council:

- A. Direct staff to amend Council Policy C015 to require at minimum an introductory report be presented to Council for initial consideration before a developer may hold a public consultation meeting if the development application:
 - A.1 is for a mixed use development;
 - A.2 is for a residential development that involves five or more units; or
 - A.3 requires an amendment to the Official Community Plan.

L.2 Zoning Amendment Bylaw No. 2910, 2021

Before the question was called, it was **MOVED** and **SECONDED** THAT Council REFER this item back to the Agricultural Advisory Committee ["AAC"] to comment on restricting additional residences in the ALR to parcels larger than 20 acres rather than 10 acres.
