#### CHIEF ADMINISTRATIVE OFFICER COMMENT/RECOMMENDATION:

#### <u>PURPOSE</u>

To provide a Parks Maintenance Policy for Council's consideration that clearly identifies the various parks service levels, the specific tasks involved in each service level and the criteria used to set park priorities.

#### DISCUSSION

#### Background:

Since 2015, the City has operated its own Parks and Recreation services, after many years under a jointservice model with Maple Ridge. Currently, the expectations and service levels provided by the Pitt Meadows Parks Department is not clearly defined. The Parks Maintenance Policy is intended to provide that clarity and will serve as a guide for future maintenance. It is expected that the service levels provided by the City meet or exceed the levels previously provided under the joint-service model. As the Parks Department gains more information on the parks and park operations, the service levels and expectations are built into the annual operating business plan.

#### **Relevant Policy, Bylaw or Legislation:**

#### C096 City Parks & Facilities Snow & Ice Policy

#### Analysis:

The Parks Maintenance Policy consists of four service levels, which can be further prioritized based on location, visibility, level of use, recreation needs and planned special events, budget, personnel, resources and environmental considerations. Priorities change throughout the year depending on these criteria. The policy is outlined in Attachment A.

The four service levels include:

#### Service Level 1 – Highest Level of Maintenance

The service objective is to maintain a neat, orderly, groomed, first-class appearance. Plants and lawns are healthy and vigorous. Lawns are uniformly green and are mowed and manicured weekly.

#### Service Level 2 – Medium to Moderate Level of Maintenance

These parks are kept neat, orderly and groomed but not to the same standard achieved in Level 1. There is additional tolerance for the effects of "wear and tear", moderate traffic and natural processes. Typically these sites are visited on a weekly basis for mowing and bi-monthly for maintenance.

#### Service Level 3 – Open Space / Beautification Plantings

These greenspaces have a neat appearance and are well adapted to play and heavy traffic with tolerance to the effects of this level of use. Typically these sites are visited on a weekly basis for litter control and garbage pick-up, weekly or bi-weekly for mowing and monthly to bi-monthly for inspection and 2-3 times a year for maintenance.

#### Service Level 4 – Preservation of Natural Conditions

The main objective of this service level is to preserve the natural habitat and ecosystem, while accommodating heavy public use. Typically these sites are visited weekly for litter pick up, monthly for inspection and maintenance when required or requested.

More information can be found in Appendices A and B1 to B4 in the policy.

The policy describes the service levels attainable with the current parks budget and resources. If further increased service levels are requested by Council, there would be resource and budget implications. The maintenance policy does not address the current condition of the City's parks and any upgrades would form part of a capital program in future business plans.

Staff are currently working towards a Parks, Recreation and Culture Master Plan, which is anticipated to be completed in 2020. The outcome of the plan may impact the service levels outlined in the Parks

Maintenance Policy. The policy will be reviewed by staff following completion of the Parks, Recreation and Culture Master Plan and any recommended amendments will be presented to Council for consideration.

# Parks Maintenance Policy

Effective Date: July 23, 2019

# I. Policy Statement

The City of Pitt Meadows is responsible for the maintenance of public parks, playgrounds, sports fields and trails within the geographical boundaries of the City. It is important to define and plan for the service level expectations. The maintenance responsibility includes, but is not limited to, the regularly scheduled parks maintenance activities consistent with the Parks Plan. The City will provide this service on a priority basis in a cost-effective manner, keeping in mind safety, budgets, personnel and environmental concerns.

# 2. Purpose

The purpose of the policy is to establish guidelines and set priorities and service levels for the maintenance of City parks. The objectives of this policy include:

- To describe the park priorities;
- To assign appropriate levels of service to the parks; to be reviewed on a periodic basis by Council;
- To describe and schedule specific tasks associated with designated service levels;
- To ensure that City-owned parks are maintained in a safe, efficient and cost effective manner;
- To prevent or reduce accidents and injuries; and
- To provide a framework to facilitate the effective reallocation of available resources in accordance with the policy and standards.

# 3. Policy

The City covers a large geographic area with various park spaces that require different levels of service. It is important to prioritize our response to ensure both public safety and appropriate resource allocation.



# 3.1. Definitions

**Aeration** means a mechanical technique to improve water penetration and soil structure by relieving compaction, often by coring.

**Artificial Turf** means a surface of synthetic fibers made to look like natural grass, but stands up to heavy use, such as in sports, and requires no irrigation or trimming.

**Baseball infield prep** means edging, weeding, topping adding rock dust & grooming the infield to meet the needs of various baseball user groups.

**Boulevard Tree** means any tree planted on the portion of land between the curb lines and adjoining property.

**Cultivation** means techniques used in preparing or maintaining ground in planting beds and may include clearing of debris, digging or loosening of the soil, harrowing, raking, and levelling the soil surface.

**Deadhead** means the removal of spent blooms from annual bedding plants to maintain a tidy appearance, prevent the formation of seed heads and encourage further blooming through the season.

**Dethatching** means a mechanical technique involving a series of vertical cuts into turf to penetrate and remove accumulated layers of decaying plant material on the soil surface.

**Display Beds** means any bed that contains a seasonal display of plant material that includes either spring flowering bulbs or summer bedding plants.

**Edging** means the mechanical control of turf adjacent planting beds or other landscape features such as walkways.

Fertilization means the act of applying a fertilizer to soil or land.

**Formal Inspection** means a visual assessment and evaluation to determine condition and maintenance requirements. This includes documentation and any reports are to be kept on file.

**Greenbelt** means linear tracts of land that are generally undeveloped and which usually separate developed tracts of land.

**Graffiti Removal** means the removal of vandalism and/or unauthorized markings to maintain the look of the facility.



**Grooming baseball infields** means to remove any debris, adding rock dust and levelling the surface by use of a powered groomer or raking manually for safety and playability.

**Horticulture** means the culture and processing of plants including plant conservation, landscape restoration, soil management, landscape and garden design, construction and maintenance.

**Informal Inspection** means a visual assessment and evaluation to determine condition and maintenance requirements. This may or may not include documentation.

*Irrigation* means provision of water by means of a mechanical system to establish and sustain growing plants.

*Lawn* means an area of short, mown grass in an open space, park or adjacent to a public building.

Manager means the Manager of Parks and Operations or the approved designate.

**Median** means a dividing area, either paved or landscaped, between opposing lanes of traffic.

*Mowing* means to cut turf grass or naturalized areas (flail mowing) with a mechanical device.

**Mulch** means a layer of organic material (i.e. shredded bark) spread over the bare surface of soil to block the loss of moisture, discourage the growth of weeds and condition the soil.

**Open Space** means all developed and undeveloped tracts of land including parks, greenbelts, trails and outdoor recreation facilities.

**Park** means an area of land having facilities for rest and recreation and which may include outdoor recreation facilities, sports fields, etc.

**Parking lot** means any parking lot used by the general public that is adjoined with parks and City owned buildings.

**Parks Caretaker** means a person employed to look after and maintenance a specific park space on behalf of the City of Pitt Meadows.

**Parks Plan** means the plan that is reviewed annually to direct the operations to be carried out by City forces for the parks seasons.



**Pest Control** means the use of mechanical, chemical or biological means to control insects, fungi or other disease of plants and turf.

**Planter** means a container for growing plants, ranging in size from permanent masonry structures to small hanging baskets.

**Park Service Level** means an area of land assigned a service level under this policy as evidenced by inclusion in Appendix A.

**Playground Formal Inspection** means the playground is inspected by an individual that holds a current Canadian Certified Playground Inspectors certificate as offered by CPSI (Canadian Playground Safety Institute).

**Pruning** means the systematic removal of branches of woody landscape plants to eliminate dead or diseased material, repair vandalism, maintain and enhance plant form, control size or rejuvenate a tree or shrub.

**Repair** means to restore grounds or fixtures to sound condition.

**Reseed/Overseed** means to replant barren areas with grass seed or to apply grass seed to an existing turf area (used to add additional grass species or to thicken sparse turf).

**Soccer preparation** means field layout and placement / securement of goal nets and maintaining the goal mouth areas for safe play during soccer season.

**Soil Amendment** means the addition of organic material to garden beds to enhance the physical quality, structure, fertility and natural water retention.

**Special Events** includes the City's signature events, baseball tournaments, charity events, and any other large user group activities.

**Sports Fields** includes athletic fields intended for sports, specialized activities, and competitive play.

Summer Season means the period of time from March 1<sup>st</sup> to September 30<sup>th</sup>.

**Top Dress** means the application of approved soil amender to turf.

**Trail** means a path or track made across an open space, accessible to the public for recreation and leisure activities.

**Horticulture Maintenance** means to culture landscape plantings including trees in lawns, boulevards and planting areas, and shrubs and/or herbaceous plants in designated planting areas.



*Trim* means to make neat and tidy by clipping or pruning.

Turf means a sports field covered with a matt-forming grass or mix of grasses.

**Urban Forestry** means the care and management of single trees and tree populations in urban settings for the purpose of improving the urban environment.

**Weed Control** means the use of mechanical means to control unwanted plants in lawn, turf, planting beds and other areas.

Winter Season means the period of time from October 1<sup>st</sup> to February 28<sup>th</sup>.

# 3.2. Roles and Responsibilities

City Council shall:

- Set and adopt the annual Parks Maintenance Budgets;
- Set and adopt the levels of service; and
- Set and adopt the park priorities.

The Manager shall ensure the implementation of the Parks Maintenance Policy by:

- Determining when and how to initiate and perform Parks Maintenance activities;
- Allocating and scheduling parks and trails resources;
- Ensuring that horticultural practices include the use of City compost where possible;
- Addressing public concerns;
- Managing the budget; and
- Recommending revisions to the Parks Maintenance Policy and Service Levels on an annual basis

The Parks staff shall carry out parks maintenance in accordance with the Parks Maintenance Policy, the Parks Plan, the approved budget and the instructions of the Manager.

# 3.3. Park Priorities

In establishing the Parks Maintenance Policy, the City must take into consideration it's financial and personnel resources. Priorities are established to provide the greatest benefit to the majority of the public. In setting priorities, consideration is given to criteria such as: location; visibility; level of use by both residents and non-residents; recreation needs and planned special events; nature of the facilities; irrigation; budget;



personnel; resources and environmental considerations. Priorities change throughout the year depending on the criteria outlined above.

As part of the annual budget review process, the Manager shall make recommendations to City Council regarding the appropriate service levels for any new parks that have been proposed.

The City has set four service levels for parks maintenance as follows and as further outlined in Appendix A – City Parks List and Associated Service Levels and Appendices BI to B4 - Maintenance Procedures and Frequencies.

**Level I**: The service objective is to maintain a neat, orderly, groomed, first-class appearance. Plants and lawns are healthy and vigorous. Lawns are uniformly green and are mowed and manicured weekly. There are few weeds and little accumulated debris. Seasonal plantings are kept lush and showy during their blooming season. This level requires frequent, regular routine maintenance of a fairly high intensity, with regular monitoring and adjustment to maintain high visual quality;

**Level 2**: The service objective is to maintain a generally neat and orderly appearance, adapted to and tolerant of expected wear and tear. Plants and lawns are healthy. Lawns are typically mowed weekly or bi-weekly. Weeds and debris are kept to acceptable levels within the limits of regular monthly visits. Seasonal plantings are not typically found in moderately maintained areas. Routine maintenance is of moderate frequency and intensity, with regular monitoring to avoid deterioration;

**Level 3**: The service objective is to preserve natural or naturalized conditions while accommodating low intensity activities (i.e. passive recreation). Plants maintain a normal, healthy appearance. Sites are visited quarterly. Weeds and debris are removed during the regular site visits. Maintenance requirements are low.

**Level 4**: The service objective is to preserve the natural habitat and ecosystem while accommodating heavy public use. Maintenance is focused on litter and debris pick-up and the sites are generally reviewed bi-monthly.

# 3.4. Hours of Operation and Staff Deployment

The City will provide Parks operation and maintenance functions in Parks within the geographical boundary of the City of Pitt Meadows, as illustrated and identified in the Appendices.



Parks maintenance work occurs year round. In general, tasks are divided into "winter season" (October 1st to February 28th) and "summer season" (March 1st to September 30th). There may be some overlap between seasons for certain tasks.

Standard hours of operation are weekdays 0700 to 1530. Weekend shifts, early morning shifts and night shifts may also be deployed as determined by the Manager. When in the opinion of the Manager where abnormal conditions exist, overtime, additional City equipment and outside forces and equipment may be mobilized within existing budgets. Un-seasonal or abnormal weather conditions may affect regularly scheduled parks maintenance activities.

# 3.5. Safety

All work shall be performed using the guidelines of the City of Pitt Meadows Health and Safety Program and the regulations of Worksafe BC. Scheduled or emergency maintenance work may at times require parks to be closed or traffic lanes to be closed or detoured in order to safely carry out work.

# 3.6. Public Concerns

Public inquiries or concerns are received and logged. Data is used to schedule for maintenance, capital upgrades and replacement.

# 3.7. Horticulture & Lawn Maintenance

Maintenance of all landscape areas including shrub & perennial beds, seasonal plantings and lawns is carried out in order to maintain an aesthetic level consistent with park service level and to preserve the health of plantings.

Maintenance of landscape areas includes: inspection; fertilization; mulching; cultivation; pest control; planting; pruning; repair; transplanting; weed control; deadheading; watering, mowing & trimming lawns and fall cleanup.

The City has set service level standards for maintenance of trees and gardens according to park service level. Scheduling of specific maintenance activities for trees and gardens is detailed in Appendices BI to B3 – Maintenance Procedures and Frequencies.

Maintenance of horticulture sites and lawn areas is typically March to October.



# 3.8. Turf Maintenance

Turf maintenance is carried out in order to maintain an aesthetic level consistent with park service level, to preserve the health and to ensure public safety.

Turf maintenance includes: inspection; soil testing; aeration; dethatching; edging; topdressing; fertilizing; liming; mowing & trimming; pest control; repair; drainage; reseeding/overseeding; weed control; infield preparation & maintenance for baseball and goal mouth maintenance & net placement for soccer on sports fields.

The City has set service level standards for turf maintenance. Scheduling of specific turf maintenance activities is detailed in Appendices B2 to B3 – Maintenance Procedures and Frequencies.

# 3.9. Installation and Maintenance of Irrigation Systems

Irrigation maintenance is carried out in order to preserve the condition of the parks. Irrigation maintenance includes: inspection; start-up; shut down; repair/ upgrading; resetting timers; adjusting sprinklers; marking heads during aeration; edging valve boxes and water ban shut off.

The City has set service standards for irrigation maintenance according to park service level. Scheduling of specific irrigation maintenance activities is detailed in Appendices BI to B3 – Maintenance Procedures and Frequencies.

Irrigation maintenance begins when ambient temperatures are above freezing. Work typically begins in March and is complete by the end of September.

For any park projects that are part of the City's Capital Project Plan, contractors conduct the initial irrigation system installation and City crews may complete the ongoing irrigation system maintenance.

### 3.10. Litter Pick-up

Litter pickup is carried out in order to maintain an aesthetic level consistent with park service level and to ensure public safety. Litter pickup includes pickup and removal of debris on the park grounds. Litter pickup does not include emptying of waste containers, which are under the purview of Public Works.



The City has set service standards for litter pickup according to park service level. Scheduling of litter pickup activities is detailed in Appendices B1 to B4 – Maintenance Procedures and Frequencies.

Litter pickup is undertaken year round.

### 3.11. Park Amenities Maintenance

Park amenity maintenance is carried out in order to maintain an aesthetic level consistent with park service level, to maintain park facilities and fixtures in good repair and to ensure public safety. Park amenities include: fencing; lighting; benches; bleachers; signs; water fountains, storage lockers; litter receptacles; washrooms; dugouts & backstops; and parking lots.

General amenity maintenance includes: inspection; painting/staining furniture; repair/replacement of structures; graffiti removal; and power washing.

The City has set service standards for general maintenance according to park service level. Scheduling of specific general maintenance activities is detailed in Appendices B1 to B4 – Maintenance Procedures and Frequencies.

General maintenance is undertaken year round.

### 3.12. Playground, Sports Court, Tennis Court & Skateboard Park Maintenance

Play space maintenance is carried out in order to maintain an aesthetic level consistent with park service level, to maintain playgrounds, courts & skateboard parks in good repair and to ensure public safety.

General play space maintenance includes: informal & formal inspections; repair/replacement of playground equipment and basketball & tennis court netting; graffiti removal, painting/staining furniture, power washing.

The City has set service standards for general maintenance according to park service level. Scheduling of specific general maintenance activities is detailed in Appendices B2 to B3 – Maintenance Procedures and Frequencies.

### 3.13. Trail, Pathway & Off Leash Dog Park Maintenance

Trails & pathways include main sidewalk corridors through all parks, secondary pathways to connect to park infrastructures and trails for cyclists and pedestrians to



travel through connected neighborhoods. Off Leash Dog Parks include fenced in areas where dogs can run freely following established guidelines.

General maintenance includes: inspection; repair; upgrading; mowing, trimming and brush cutting; pruning; invasive plant removal.

The City has set service standards for general maintenance according to park service level. Scheduling of specific general maintenance activities is detailed in Appendix B4 – Service Level 4 Maintenance Procedures and Frequencies.

#### 3.14. Urban Forestry Program

Urban Forestry management is carried out in order to maintain an aesthetic level consistent with park service level and to maintain a healthy forest canopy throughout the City. This includes trees in parks, on boulevards & medians, and natural greenbelt areas or open spaces.

Urban Forestry maintenance generally includes: inspection; assessments; pruning; removal; planting; watering; assist Development Services with permits, bylaws and new development on City owned land.

Urban Forestry maintenance is conducted city-wide. For simplicity, the associated tasks and frequencies have only been identified in Appendix B4 – Service Level 4 Maintenance Procedures and Frequencies.

### 3.15. Contractor Management

Contractors may be hired as required for speciality work that cannot be completed by City staff or to complement the work of Parks staff in order to maintain the desired levels of service that are set forth in this policy.

Staff oversee the work of the contractors to ensure that the work is being completed to an acceptable level set forth through a scope of work determined by the City.

Contractors work may include, but it not necessarily limited to: grass mowing & trimming; brush cutting; tree pruning; hazard tree removal, aerating grass sports fields, irrigation repairs & install; hanging basket maintenance; landscape maintenance; irrigation install and repairs; waste removal; portable toilet installation & maintenance; Christmas light install & removal. Parks staff work with the City's Procurement & Contractor Administrator to review the services on a yearly basis.

The City has set service standards for general maintenance according to park service level. Scheduling of specific general maintenance activities is detailed in Appendices B1 to B4 – Maintenance Procedures and Frequencies.



### 3.16. Installation and Maintenance of Christmas Lights

Installation and maintenance of Christmas lights is carried out in order to maintain an aesthetic level to celebrate the holiday season, to celebrate Pitt Meadows Christmas and to ensure public safety.

Installation and maintenance of Christmas lights includes: inspection; installation; removal; replacing bulbs and resetting timers.

The City has set service standards for Installation and maintenance of Christmas lights and scheduling of specific installation and maintenance is detailed in Appendix BI – Service Level I Maintenance Procedures and Frequencies.

Installation and maintenance of Christmas lights is undertaken from October to the end of January.

### 3.17. Repair and Damage Caused by Vandalism

Repair of damage to parks grounds, facilities or fixtures caused by vandalism is carried out in order to maintain an aesthetic level consistent with park service level, to maintain park facilities and fixtures in good repair, to minimize recurrence and to ensure public safety. Repair of damage caused by vandalism includes repair/replacement of damaged plantings or fixtures.

Repair of damage caused by vandalism is undertaken year round, as required.

# 4. Procedures and Guidelines

The Parks Maintenance Policy establishes the service levels, priorities and provides clear direction for the City's activities for consistency and clarity both for City staff and the general public to understand how the City of Pitt Meadows maintains the parks.

Any significant changes to the Priorities or Service Levels will require Council's approval.



# 5. Exclusions

The Parks Maintenance Policy specifically excludes the following:

- I. Dike Trail Network;
- 2. Sidewalks and public rights-of-way;
- 3. Utility rights-of-way;
- 4. Greenbelts and/or environmental protection areas;
- 5. Road rights-of-way and medians not specifically designated under this policy;
- 6. Sports fields and recreation facilities not specifically designated under this policy;
- 7. Streetscapes and planters not specifically designated under this policy;
- 8. All other parks or open spaces not specifically designated as Priority Parks under this policy as defined in Appendix A Priority Parks List.

# Appendix BI –Service Level I Maintenance Procedures & Frequencies

### Level I - Highest level of maintenance

**Objective:** The parks are maintained for first-class appearance. They are in general impeccably clean and well-groomed. Typically these sites are visited on a weekly basis.

- Appearance Standard Plants are kept pruned and manicured so they are in exceptional condition. Seasonal color and plantings are kept lush and aesthetically pleasing.
- **Typical Locations** A small, high profile section of a larger greenspace. Some City facility entrances and intimate areas that are highly visible/high public profile, parks with high public use.
- **Plant Characteristics** Specimen trees and native plants, unique and unusual plants are used.
- Traffic Activity Levels Pedestrian "wear and tear" is expected.
- **Maintenance Practices** Maintenance aims to regulate and monitor closely, the effects of public use.
  - a. Gardens are monitored and attended to weekly with enhanced attention to their health and appearance.
  - b. Lawns are cut and manicured weekly during the growing season with grass clippings mulched and left on-site. They are kept in good condition through practices of aeration, dethatching and fertilizing during spring and fall months. They are generally free of weeds, invasive plants, litter and debris.

### Appendix B2 –Service Level 2 Maintenance Procedures & Frequencies

#### Level 2 – Medium to moderate level of maintenance

**Objective**: These parks are kept neat, orderly and groomed but not to the same standard achieved in Level I. There is additional tolerance for the effects of "wear and tear", moderate traffic and natural processes. Typically these sites are visited on a weekly basis for mowing and bi-monthly for maintenance.

- Appearance Standard Plants and lawns are healthy, green and regularly mowed to an acceptable height range. Few weeds or noxious invasive plants, and little to no accumulated debris or litter. Seasonal plantings are kept lush and attractive.
- **Typical Locations** High-profile segment of a larger greenspace and sports fields.
- **Plant Characteristics** Specimen trees and plantings that include shrubs, perennial and native plants.
- **Traffic Activity Levels** Medium to moderate traffic; minor deterioration is acceptable. Maintenance may include adjustments to such "wear and tear".
- **Maintenance Practices** Routine maintenance of medium to moderate frequency and intensity, with regular monitoring.
  - a. Gardens are monitored and attended to monthly with enhanced attention to their health and appearance.
  - b. Lawns are cut and manicured weekly or during the growing season with grass clippings mulched and left on site.

### Appendix B3 –Service Level 3 Maintenance Procedures & Frequencies

### Level 3 - Open space/play and beautification plantings

**Objective:** These greenspaces have a neat appearance and are well adapted to play and heavy traffic with tolerance to the effects of this level of use. Typically these sites are visited on a weekly basis for litter control and garbage pick-up, weekly or bi-weekly for mowing and monthly to bi-monthly for inspection and 2-3 times a year for maintenance. Parks, medians, boulevards, traffic islands, street plantings and bulbouts maintenance increases between May and July each year.

- Appearance Standard Vegetation is healthy, grass is kept trimmed and weeds are kept to a minimum.
- **Typical Locations** Boulevard and corner plantings, median plantings, traffic islands, bulbouts, parks, playgrounds and recreational areas.
- **Plant Characteristics** Specimen trees, shrubs, perennial and native plants and grasses with low maintenance needs.
- **Traffic Activity Levels** Can withstand moderate to frequent use.
- **Maintenance Practices** Routine maintenance of moderate frequency to control and prevent deterioration and removal debris and litter.
  - a. Gardens are monitored and attended to monthly with enhanced attention to their health and appearance.
  - b. Lawns are cut and manicured weekly or bi-weekly for mowing or every 3 weeks during the growing season with grass clippings mulched and left on site.
