MOVED by Councillor Bell, **SECONDED** by Councillor Elkerton, THAT Council:

- A. Receive the report from the Manager of Community Development entitled "Pitt Meadows Gun Club and Shooting Range Regulation Options"; AND
- B. Direct Staff to proceed with permitting the Pitt Meadows Gun Club to resume operation subject to following conditions:
 - B.1 Direct Staff to provide the RCMP Firearms Officer with the City's consent to allow the PMGC to resume operation subject to RCMP range inspection and approval; AND
 - B.2 Direct staff to prepare amendments to the Business Licensing and Regulation Bylaw in relation to shooting ranges, and report back to Council with proposed amendments; AND
 - B.3 Direct staff to request that a business license application be submitted by the Pitt Meadows Gun Club within 30 days of adoption of amendments to the Business Licensing and Regulation Bylaw relating to shooting ranges, or upon no further consideration of amendments; AND
 - B.4 Direct staff to refer matters concerning safety or environment to appropriate jurisdictions as received, through the City's Bylaw Enforcement Department as directed by Policy 014;
 - B.5 Direct staff to request ongoing water and soil testing from the Pitt Meadows Gun Club;
 - B.6 Hours of opening be permitted on Wednesdays from 18:00 to 21:00 hours and on Sundays from 10:00 hours to 16:00 hours; AND
 - B.7 Special events requested outside of permitted hours be published by the Pitt Meadows Gun Club prior to January 31 each year, except in the year 2018 where special events outside of permitted hours be

- published prior to April 30 with no more than 10 special events each year; AND
- B.8 A berm or fence barrier with the suitable option to be determined be constructed; AND
- B.9 A community member be added to the Pitt Meadows Gun Club Board: AND
- B.10 A "Good Neighbour Plan" be drafted; AND
- B.11 Direct Staff to report back of Council at the end of May in a Council in Committee meeting to assess progress on issues outstanding; AND
- C. Grant first, second and third readings to: the Discharge of Firearms Bylaw Amendment Bylaw No. 2802, 2018; Noise Control Bylaw Amendment Bylaw No. 2803, 2018; and, Bylaw Enforcement Notice Bylaw Amendment Bylaw No. 2804, 2018.
