# 5. <u>Agricultural Land Reserve Exclusion Application for 18601 Lougheed</u> <u>Highway (File 6635-20-2020-06)</u>

Alex Wallace, Manager of Community Development, provided an overview of the Staff Report including a PowerPoint presentation which is included as Attachment 2 and forms part of the original minutes.

The Applicant participated by telephone and spoke to the engagement of an environmental consultant, history of and future use for the property.

- A. Given the historical use of the property, direct Staff to forward to the Agricultural Land Commission, with a recommendation of support, the application to exclude the land at 18601 Lougheed Highway from the Agricultural Land Reserve; AND

- C. Direct Staff to include language in the exclusion application that references the importance of both sloughs and Council's recommendation that the Applicant seek out the appropriate riparian approvals from the Province prior to any new activities on the property.
