<u>DISCUSSION</u>			
Background:			

Beginning on June 27, 2019, the City of Pitt Meadows announced its intention to conduct a Police Services Review. The purpose of the review was to examine how local RCMP resources were deployed with the goal of enhancing services and responsiveness.

Since then, the City used a variety of communications to keep the community informed. For a complete summary of communications activities see: Summary of Communications, Information and Community Engagement Activities (Attachment A).

More recently, and following the EPC of February 18, the City provided an opportunity for further community feedback using the online platform haveyoursaypittmeadows.ca.

Community Engagement Summary:

The following section summarizes community feedback gathered during the February 18, 2020 EPC meeting and feedback from haveyoursaypittmeadows.ca, the City's online community engagement platform that was open from February 19 until March 1, 2020.

Summary of Feedback:

Approximately 100 people attended the February 18, 2020 EPC. During the session, 14 people provided comments. Beginning on February 19, the City provided an opportunity for residents to provide feedback online in relation to an independent RCMP detachment for Pitt Meadows. 60 people provided online comments, amounting to a total of 74 comments received.

All online comment submissions (unedited) are provided in Attachment B and a summary of comments made at the February 18, 2020 EPC meeting are provided in Attachment C, as per the draft minutes from that meeting.

With reference to the table below, the comments were organized into four categories: Support; Support with caveat; Not supported and Undetermined.*




Table - Categorized Responses

An individual who attended and commented at the EPC may have also chosen to make a comment online therefore; potentially the results may have counted and categorized the same individual's comments twice.

^{*}Please Note: Effort was made to accurately assess and categorize each submitted comment regarding perspective of an independent RCMP detachment. Since subjective interpretation was occasionally required, all unedited comments have been included in Attachment B for full review and individual assessment.

Themes:

Of the 74 responses, the following themes* emerged:

- 62 percent of respondents were in support (or support with caveat) of an independent RCMP detachment. 20 percent were not in support and 18 percent were undetermined.
- 2. Concerns about increased property taxes.
- 3. Concerns about the cost and availability of resources.
- 4. Lack of clarity for the justification for an independent detachment relative to crime rates.

Please provide any comments you may have regarding the Police Services Review and recommendation for an autonomous Pitt Meadows RCMP Detachment.	Summarized as
I wholeheartedly support Pitt Meadows having our own autonomous RCMP detachment.	Support
Maple Ridge and Pitt Meadows are two separate communities with separate issues, especially where criminal activity is concerned. And frankly I'd like to keep it that way.	
Maple Ridge is in need of more officers to handle some of their issues. And while I do not begrudge Maple Ridge, I do not feel this should be paid for by the Pitt Measows tax payers as it is with our current shared RCMP.	
Pitt Meadows NEEDS to have a visible RCMP presence, which it currently does not. Otherwise we could easily have the issues that Maple Ridge and other larger communities have, which so far we have been fairly lucky to avoid on a large scale. However not altogether. I feel chart 2 on page 7 is not an accurate assessment of our actual criminal activity in Pitt Meadows. While it shows RCMP calls have decreased, I feel this graph simple shows the number of reported crimes have decreased. The residents of Pitt Meadows have grown tired of calling in non-emergency criminal activity to wait hours (or to not have an officer show up at all) to a reported crime in action. So they just post on social media, where most encourage them to report it after the fact, but often that advice falls on deaf ears.	
We do not want the criminal activity that occurs in Maple Ridge or other areas, yet we do have it. Fortunately in a much smaller scale. I feel with our own Pitt Measows RCMP detachment we can eliminate some of the criminal activity we currently have and prevent any escalation of criminal activity in our community. Let's keep Pitt Meadows safe for all who live and visit here. As a tax payer, the safety of my family is by far my biggest concern. So again, I fully support Pitt Meadows having our own RCMP detachment. Especially if it isn't going to increase our taxes. But frankly, I would support it even if it would slightly increase our taxes! My family's safety is worth it.

The current model is working. The report indicates that our crime rates are low. We do not have a need to make this drastic change at this time. It does come with added costs (ie renovations) which are NOT needed at this time. I am very concerned with this council's willingness to spend our tax dollars so freely. There are already many major projects that this council has already committed to such as the \$15 million dollar firehall and the significant tax increases you provided to yourselves. There does not seem to be an end to the amount of money you feel you have available to spend, but it is OUR tax dollars you are using. Our community is SAFE. We do not need to see RCMP members watching our kids play their sports or sitting in coffee shops as you think is important. I feel this is NOT a good use of my tax dollars. I also feel you are NOT listening to people even though you say you do. It is a sham. You only defend your pre determined positions rather than actually listen to people. The issues that were raised in the report in terms of members travelling to Maple Ridge can be addressed by dialogue. You do not need to walk away from a model that is working to keep us safe. It will take some maturity and genuine desire to work towards a mutually agreeable solution. You do not need to create your own sandbox.

It seems like this has been a pre-determined process and that council has already made up their mind and comments will not make a difference. This concerns me as council says they listen to residents but that does not seem to be the case from my perspective. I see no need to change the current policing structure. The current structure is working for us as evidenced by our low crime rate. Although this council may want to see RCMP members in our parks watching our children play their sports, I do not think this is a good use of resources. I also don't think this is realistic. They have better things to do with their time. I think the terms of reference were super narrow and only allowed for the recommendations this council wanted to see. If we are considering an independent RCMP detachment why was this option not compared to it's own municipal force? This seems reasonable to consider all options to determine not only the best one but the most cost effective one as well. I am concerned about the unknown costs for things such as the new jail that will be needed. How can we commit to this when the costs are as of yet undetermined. This council (as you portray yourself as one whole entity who are unanimous) dismissed any legitimate concerns raised at the EPC meeting such as members not wanting to work in a detachment that has a slower pace. It will be difficult to staff these positions and definitely having a smaller detachment will make it more challenging to fill vacant positions or for those on various leaves. This will likely come with increased costs such as overtime or looking outside our independent detachment. Our current model is working. This is not the time to make a change. This council has already committed our tax dollars to too many

I would support an autonomous RCMP police detachment so long as it does not increase taxes and we are receiving a superior service. I feel that more information about the upfront costs required for the set up and building needs are needed before a decision is made. I would like to know what the options are and the costs for the reno versus new build and what the location options are for a few building. Also, does the city staff have capacity to take this on and oversee the transition with so many other larger projects? Will more staff be hired and is that included in the existing operating budget? Thank you for receiving my feedback.	Support with caveat
I'm very much in favour of an autonomous Pitt Meadows RCMP Detachment. The \$5.4 million budget is already being spent with an integrated detachment, however, officers are most often in Maple Ridge and are dealing with more Maple Ridge calls. Because of this and because the integrated detachment is situated in Maple Ridge, Pitt Meadows does not have much of a police presence on a day to day basis. Based on the figures presented, Pitt Meadows is not seeing value for the money we are spending with an integrated unit. In a way, we are subsidizing Maple Ridge residents with the officers that could otherwise remain within our PM border. It just makes sense to use our existing budget to have our own detachment where the officers remain here in PM. Not only will this help to create more of a direct relationship between RCMP officers stationed in PM and our community, but also improve responsiveness and offer higher quality service. I also feel that having more of a police presence on a day to day basis will help to deter the increase of crime in our area as there will be more officers available to patrol problem areas and respond more readily to calls. There is also the issue of population growth over the next 20 years which is another factor to favor having our own detachment. In my opinion, we would be remiss not to go the direction of an autonomous detachment if it means we still maintain our budget without an increase in property taxes (not including the \$1.5 million from reserves needed to put toward creating a detachment location). 'I attended the Police Services Review meeting on February 18th and I did voice my comments there. However, I wanted to clarify some points that seem to get lost in the conversation.

Not supported

- 1) If the crime rate is low in Pitt Meadows and the current Policing model is working what is the need to make any change? If we had a crime problem I would understand and support a change. The only reason that was presented by Council last night was the want to have Police officers more connected to our city. The example that was provided was the desire to have on duty Police officers at sporting and community events and clear for calls if needed. I do not believe that having our own RCMP Detachment will fulfill this request and even if it did what does it provide us? The other reason was need to reduce the time members spend traveling from Maple Ridge to Pitt Meadows. I am not sure how this is F27 issue. Currently, Members start their shift in Pitt Meadows, take files in Pitt Meadows and end their shift in our town. The only need to travel to Maple Ridge would be to transport prisoners to cells. This travel will not be avoided even if we have our own detachment as the likelihood of Pitt Meadows having our own cells is low due to cost. What is the real cost to have our own detachment. First, we would need to expand our current building or replace it which will be significant. Second, there are many police services that Pitt Meadows currently has access to that we would have to start paying for, these include:
- ECOMM: we would need our own dispatch channel which we currently share with Maple Ridge. This is a significant cost that several other agencies have decided to share with other agencies in order to save money. If we separate, we would have to share the cost with Maple Ridge or pay for our own channel/dispatch.
- IDENT: Maple Ridge would not simply allow Pitt meadows to use their forensic Identification services at no charge. We would have to our own IDENT or pay to use Maple Ridge ERT: Pitt Meadows would have to either supply members to the integrated ERT services or pay to use them.
- IHIT: if there is a homicide in Pitt Meadows, we currently use IHIT which Ridge Meadows RCMP is part of as we have members seconded there. For homicide investigations we would have to either send members to IHIT or pay for the services.
- Street Crime or plain clothes units: Currently we have access to plain clothes members if needed. Plain clothes members are a required section in order to investigate significant serious crime (such as B&E suspects). Pitt Meadows would not have a plain clothes Unit and would have to ask Maple Ridge to use theirs (if available) and at a cost.Traffic Section: we currently

have a dedicated Traffic Unit that can address and target traffic issues in our town. Patrol members can also do this but it would be a secondary function if and when time allows.	
- Jail staff: we would either have to continue using Maple Ridge cells that we currently use for free. We would have to start paying to use their cells or build and staff our own cells. This is a significant cost that other departments in the GVRD contract out.	
In conclusion, I believe that having a separate RCMP Detachment in Pitt Meadows will reduce our service, reduce our ability to get resources when needed and will cost us more. I am also concerned that the real cost of having our own detachment will be significantly higher than projected. I am also concerned that our taxes will be increased to fund this initiative.	
I do not support having our own RCMP Detachment and I do not understand the need to make the switch. I also believe that the cost to build or expand our Police building would be better spent on other infrastructure such as a pool.	
If this stays within budget as stated and does not increase our taxes but provides more visible policing in our town, it sounds logical many residents are concerned of future costs of growth affecting the budget. We do not want to spend millions on a new police detachment building; especially with the huge expense of the upcoming Fire Hall replacement. The positives of a community police force have merit as long as we do not have tax increases to sustain this.	Support with caveat

We are supposed to be an Integrated Police Dept and that works when the two cities are similiar in size both population and geographically. Over the past 10 years, Maple Ridge's growth in popn, size and crime has resulted in the Integrated Dept morphing into ONE dept where the resources are not able to be allocated as intended. The officers supposed to be dedicated to PM are not as they spend time in MR for parade, dropping of exhibits and the majority of them do start/stop in MR for the commaderie which was not the model intended. The commanding officers NCO are not overseeing them in PM as I understand it so while it might look on paper as we are well served with 23 to give us a good cop to pop, when those 'cops' arent IN PM, we aren't being serviced. PM community model will look very different than MR based on our citizen make up. And so the police force needs to look different. It appears that MR is not being held accountable for the lack of RCMP service being provided to Pitt Meadows, even though we pay for it. However, in my own experience, I have dealt with the RCMP on several occasions (usually in the form of 911) and the response has been exceptional. They have shown up in a very short time frame and been a pleasure to deal with.

Based on a lot of the information provided and the numbers, I feel that there needs to be discussion with MR on the current level of service provided and less need for our own detachment. I look forward to more information being provided.

I understand that the 2020 budget has been approved and has the funds available this year, but how can we see the previous years amounts paid to Maple Ridge for policing services?
