- Creation of 32 childcare spaces in alignment with the City's Childcare Needs Assessment;
- Alleviates concern of parents with having children in larger daycare settings by utilizing 4 classrooms with a capacity of 8 children;
- Challenge to find daycare for children under 36 months of age;
- Outdoor play space proposed is anticipated to be a shared play space for infant/toddler program and is requesting to use small section of City property; Initially the proposed play space is 560 square feet with 288 square feet being City property;
- Revised proposal of outdoor play space would ensure the water access grate would be outside of play space, resulting in only 248 square feet of City property being used.

Mayor Dingwall invited speakers for the first time.
