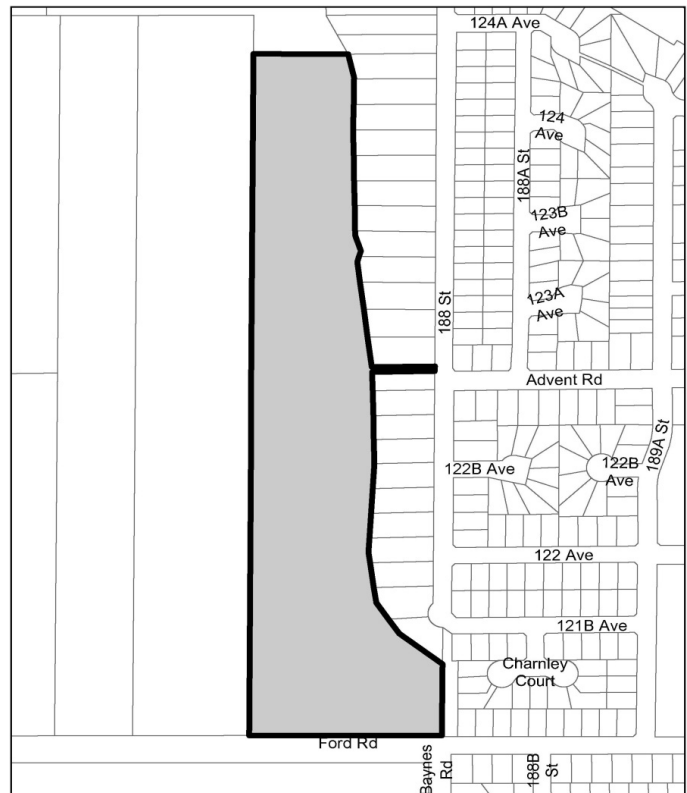

The proposed renewal of Temporary Commercial Use Permit will be considered by Council at a meeting to be held on **Tuesday November 17, 2020 at 7:00 pm** in the Council Chamber of the Pitt Meadows City Hall, 12007 Harris Road, Pitt Meadows, B.C.

Council may by resolution:

- a) authorize the renewal of the Temporary Commercial Use Permit; or
- b) authorize the renewal of the Temporary Commercial Use Permit with conditions; or
- c) refuse to authorize the renewal of the Temporary Commercial Use Permit.
