1.3 Recommended Updates to City Bylaws Regarding Smoking in Public Places. (File 4940-02/18)

Ms. Lisa Grant, Director of Community Services provided a Powerpoint presentation which is included as Attachment 2 and forms part of the original minutes. Ms. Grant provided an update on new cannabis legislation and summary of the staff report.

MOVED by Councillor Stark, **SECONDED** by Councillor Miyashita, THAT Council direct Staff to include in any bylaw amendments prohibition of smoking on City right of ways.

- A. Direct staff to prepare amendments to the Tobacco Sales and Smoking in Public Places Regulation Bylaw No. 2358, 2008 to include:
 - A.1 cannabis, e-cigarettes, vaping and smoking of other non-tobacco products;
 - A.2 prohibition on smoking within 7.5 m of transit shelters and stops;

- A.3 prohibition on smoking on City trails, parks, and dikes;
- A.4 prohibition on smoking within 10 m of municipal parks including playing fields, sports fields/courts or playgrounds, schools, and child care facilities;
- A.5 prohibition on smoking on City streets during outdoor public events;
- A.6 prohibition on smoking in places of assembly;
- A.7 prohibition on smoking on any business premises to which members of the public are admitted generally or as members of an organization or club;
- A.8 exemption for aboriginal cultural activity use of ceremonial tobacco and smoking by actors as part of a stage or theatrical performance;
- A.9 some housekeeping, grammar and spelling corrections and new definitions as needed; AND
- B. Direct staff to prepare an amendment to the Business Licensing and Regulation Bylaw No. 2643, 2014 to include regulations for e-cigarettes, vaping and other non-tobacco products; AND
- C. Direct staff to prepare an amendment to the Notice and Enforcement Bylaw No. 2439, 2009 to include fines for cannabis, e-cigarettes, vaping and other non-tobacco products.

Before the question was called it was:

MOVED by Councillor Dingwall, **SECONDED** by Councillor Elkerton, THAT Council increase the prohibited distance in item A.2 to 10 metres.
